



Tolleson Elementary School District #17 Tax Credit Request Form Information

The Arizona tax law (ARS§ 43-1089.01) allows taxpayers a TAX CREDIT of up to \$400 per household if they contribute to extracurricular activities in public schools.

What is an extracurricular activity?

Extracurricular activities are optional, noncredit, educational activities that are offered before, during, or after school hours. Examples include enrichment activities, field trips, after school athletics, the “Arts” which includes Art, Band, Music and Choir and after school clubs.

Who is eligible?

This tax credit is available to all Arizona individual taxpayers regardless of whether or not they have children in school. An *individual* can contribute and receive tax credit for any amount up to \$200, or a *couple filing jointly* can contribute up to \$400.

Where does the money go? Does it have to be \$400?

You may indicate which school and which program you would like to support or you can designate your money to be given to the school(s) that has the greatest need. The amount of the tax credit you take, does not have to be for the total allowable amount of \$400. You can make a difference to our schools with contributions of \$50, \$75, or \$100.

How can I take advantage of the tax credit for 2022?

You can make contributions anytime throughout the year simply complete the following form and bring it to our District Office or mail the form and your contribution by the deadline date of April 15, 2023. *Please note that* contributions received from January 1, 2022 through April 15th, 2023 can be claimed on your Arizona State Tax Return for tax year 2022. If you choose to **mail** your tax credit contribution it **must be** postmarked no later than April 15, 2023.
