Tolleson Elementary School District Student Internet User Agreement

Students and parents/guardians of students must understand that their student may have access to the Internet through the use of filtering software and supervision, Tolleson Elementary School District limits access to inappropriate materials on the Internet. Students and parents should be aware that no filtering system is completely effective in preventing access to all inappropriate materials, and it is the student's responsibility to follow the above regulations and the direction of staff.

Instructional Assurances

When the Internet is being used, the following assurances will be made:

- All activities using the Internet will have a curriculum focus and well-defined purpose.
- Internet safety and etiquette rules will be introduced before beginning an Internet project.
- All searching activities will be structured using age-appropriate search engines. All teachers will provide instruction and scaffolding necessary for students to use research ethically.
- Any information or student work published or submitted through the Internet is not private; no addresses or student last names will be published on District Internet web pages.
- Social Media and Chat rooms will only be available through approved media sites and will be monitored.

Student Agreements

Students who utilize the Internet at the school agree to the following statements:

- I will use the Internet for appropriate educational uses only.
- I will report any misuse (inappropriate games, e-mail, chat rooms, social media, etc.) of the Internet to my teacher.
- I will play education related games only under the supervision of my teacher.
- I will not give out personal information such as my full name, home address, telephone number or any personal identifiable data.
- I will tell my teacher right away if I come across any information that makes me feel uncomfortable or that I know I should not be looking at.
- I will not send my picture or other personal information to another person.
- I will follow all Internet safety and etiquette rules while I am working online.
- I will abide by all copyright guidelines.
- I will not do anything to the local network or other networks that would disrupt the use of the systems by others.
- I will not subscribe to or purchase services or products through the Internet.
- I will not participate in or be part of any Cyber Bulling of any kind.
- I will not access any social media sites or chat rooms unless that site has been approved by the district and is used for educational purposes.

Disciplinary Action

Students who misuse the Internet will be disciplined as follows:

- Violations will result in the loss of use and access to the Internet and /or computers for a length to be determined by the school administration, Lab teacher, and /or teacher.
- The school in accordance with student discipline guidelines for inappropriate language or behavior may determine additional disciplinary action.
- When applicable, law enforcement agencies may be involved.

In summary: I will be held responsible for all of my actions online. My actions may be monitored and tracked while I'm using the school's computers and network. I will not download inappropriate copyrighted material. I will **not** disclose any personal information about myself or my family. I will notify my teacher if I receive communication or access a website that I feel is inappropriate.
